### SECTION 4 – FIRST AID MEASURES

#### Description of necessary first aid measures

<b>Inhalation</b>	If inhaled, remove to fresh air. In case of inhalation of decomposition products in a fire, symptoms may be delayed. The exposed person may need to be kept under medical surveillance for 48 hours. Get medical attention if symptoms occur.
<b>Ingestion</b>	Do not induce vomiting unless directed to do so by medical personnel. Get medical attention if symptoms occur.

Injuries may not appear serious at first but within a few hours tissue becomes swollen, discoloured and extremely painful with extensive subcutaneous necrosis. Surgical exploration should be undertaken without delay. Thorough and extensive debridement of the wound and underlying tissue is necessary to minimise tissue loss and prevent or limit permanent damage. Note that high pressure may force the product considerable distances along tissue planes.

<b>Large spill</b>	Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with noncombustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). If emergency personnel are unavailable, contain spilt material. Suction or scoop the spill into appropriate disposal or recycling vessels, then cover spill area with oil absorbent.
