Spilt material may result in a slip hazard and should be absorbed into dry, inert material (e.g. sand, earth or vermiculite), which then can be put into appropriately labelled drums for disposal by an approved agent according to local conditions. Residual deposits will remain slippery. Wash area down with excess water. If contamination of sewers or waterways has occurred advise the local emergency services.</p>
